In exercise of the powers conferred by sub-section (6) of Section 5 of the Administrative Tribunals Act, 1985, I hereby authorise myself and Mrs. Urmita Dutta (Sen), Hon'ble Member(Judicial) of the West Bengal Administrative Tribunal to function as a Bench consisting of a Single Member and exercise the jurisdiction, powers and authority of the Tribunal in respect of the cases listed in the cause list of our respective Benches with regard to the dates i.e 22/01/2020, 24/01/2020, 27/01/2020 and 28/01/2020 under the Headings "New Application" and 'Admission Hearing' subject to the following procedure:-

- (1) that the case does not involve validity of any statutory provision or interpretation of any of the provisions of the Constitution.

- Notwithstanding anything contained in the previous paragraphs if at any stage of the proceedings it appears to the Single (iii) Member that the case is of such a nature that it ought to be heard by a Bench of two members, he may refer it to the Chairman to transfer it to a Bench of two members.
