Management Cell, West Bengal. The respondent no. 2, Chief Conservator of Forests, Personal Management Cell, had moved the Department of Forests by sending a letter to the Principal Secretary to the Government of West Bengal, Department of Forests on February 22, 2012. The grievance of the applicant is that no action has been taken on the said letter dated February 22, 2012 till date. The applicant in the meantime retired from service on July 31, 2014.

None appears on behalf of the state respondents in spite of service of notice as reflected from the affidavit of service filed by the applicant. Since the issue of pay protection of the applicant is pending for decision before the respondent no. 1, Principal Secretary to the Government of West Bengal, Department of Forests from the year 2012, we are of the view that the respondent no. 1 should take a decision with regard to pay protection of the applicant within a reasonable period of time.

In view of our above findings, the respondent no. 1, Principal Secretary to the Government of West Bengal, Department of Forests is directed to take decision whether the applicant is entitled to get pay protection from the date on which his junior one Sirajul Haque got higher pay as Forest Ranger on the basis of letter dated February 22, 2012 issued by the Chief Conservator Forests, Personal Management Cell, West Bengal
