Government employee is entitled to get pension after rendering ten years of service in terms of the provisions of Rule 67 of West Bengal Services (Death-cum-Retirement Benefit) Rules, 1971 (in short, the DCRB Rules, 1971). In the instant case, there is shortfall of four months and fifteen days in qualifying service for grant of pension to the applicant. Rule 36 of the DCRB Rules, 1971 provides that the State Government has the discretion to condone deficiency in qualifying service for grant of pension upto the period of six months. In the instant case, the shortfall of the applicant in qualifying service for grant of pension can be condoned by the State Government by invoking the provisions of Rule 36 of the DCRB Rules, 1971. On consideration of the background of joining in the post of Constable of Police by the applicant, we are of the view that the shortfall in qualifying service for grant of pension of the applicant should be condoned by the State Government.

In view of our above observation, we direct the respondent no. 1(a), Principal Secretary to the Government of West Bengal, Department of Home (Police) for condonation of shortfall of four months and fifteen days in qualifying service for grant of pension to the applicant by invoking the provisions of Rule 36 of the DCRB Rules, 1971 within a period of 16 (sixteen) weeks from the date of communication of the order and to take necessary follow up action within a period of 8 (eight) weeks thereafter.
