The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

The applicants have filed this application praying for a direction to the respondent authorities to increase the ratio to 1.5 in the interview for the post of Assistant Director (Agriculture). From the submissions and the records, it appears that the applicants were participants in the selection process vide Advertisement No. 5/2023 conducted by the West Bengal Public Service Commission for the post of Assistant Director (Agriculture). However, none of the applicants could qualify for the final round of the selection - the interview, since they could not score high enough in the Preliminary Screening Test. Copy of Notification No. 23 dated 10.01.2025 published by the Commission shows the cut off marks required to qualify in the interview. The applicant No. 3 to 8 belongs to Reserved category for which the cut off marks for interview was fixed at 65.75 for OBC (A), 66.75 for OBC (B), 63.25 for SC and 52.50 for ST. Applicant no. 1 to 2 belong to Unreserved category, cut off for this category was also fixed at 66.75. The table below explains the marks obtained by the applicants

From the above chart, it is evident and not disputed that these applicants who had participated in the Preliminary Screening Test could not qualify for the interview since their scores were lower than the cut off marks as set by the Commission for different categories. Hence, their main argument is that if the Commission had raised the ratio from 1.2 to 1.5 for the interview; they would have got a fair chance to qualify in the interview.

Having heard both the sides and after examination of the records, it is clear to this Tribunal that the applicants, being unsuccessful, assumes that a higher ratio for interview would have given them a chance to qualify. Asking for such a direction to the Commission is not only preposterous but unreasonable. For, it is the Commission's

prerogative to fix such ratio. The applicants' plea is simply presumptuous and devoid of any merit. They had participated knowing very well the selection criteria, but being unsuccessful, they are now pleading for change of ratio. The Tribunal is clear that such prayers are without any merit. Therefore, this application is disposed of without passing any orders.
