The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638 – WBAT / 2J-15/2016 dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

Mr. Basu presents a copy of the High Court's order in WPST No. 30 of 2024 and prays for an interim direction to the respondent authorities restraining them from giving effect to its order No. 2663 dated 31.07.2023. By this order, the respondent authorities have withdrawn the 25 years MCAS benefit earlier given to the applicant. Submission on behalf of the respondent department is that in terms of the order No. 2663, Additional District Magistrate (L.A.), Bankura has already executed the order vide two Memos 880 and 884 dated 21.08.2023 and 22.08.2023 respectively. Submission of the respondent side is that applicant has not assailed these two orders. Mr. Basu submits that flowing from the main order 2663, these two operational orders were also issued. By assailing the main order, subsequent operational orders are also assailed. From the submissions of the learned counsels, it is understood that such benefit of 25 years MCAS was withdrawn due to a disciplinary proceedings initiated against the applicant.
