The matter is taken up by the Single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24<sup>th</sup> December, 2020 and 456-WBAT/2J-15/2016 dated 16<sup>th</sup> July, 2021 issued in exercise of the powers conferred under sub section (6) of Section 5 of the Administrative Tribunals Act, 1985.

Affidavit of service filed by the applicants be kept on record.

The instant application has been filed basically challenging the withdrawal of the facility granted by the Director of Agriculture and Project director of ATMA. However, the Deputy Director of Agriculture(WBP) and Project Director of ATMA Cooch Behar vide his Memo dated 26.08.2019 has withdrawn granted by the Director of Agriculture & Ex-Officio Secretary & SNO-ATMA.

However, the counsel for the respondents has raised preliminary objection on the point of jurisdiction as the applicant was appointed as Assistant Technology Manager under ATMA, Cooch Behar and the Deputy Director of Agriculture and Director of Agriculture are the ex-officio member of contractual project of ATMA, which is a Government Project, wherein the applicant was appointed in contractual post. Therefore, the applicant is not holding a civil post and this Tribunal do not have the jurisdiction to entertain this instant OA. However, the counsel for the applicant has prayed for some time to satisfy the court on the point of jurisdiction. Prayer is allowed.
