(i) Method – By way of promotion on seniority basis from the post of Public Health Nurse to the post of Senior Public Health Nurse having minimum of 3 years working experiences as Public Health Nurse...".

Having submitted on above lines, Ms. Shaw prays for a direction to the respondent authorities to consider their representations and promote them to the post
