The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The applicant has prayed for a direction to the respondent authorities to expedite taking decision in the matter of his proposal for appointment under compassionate ground. As understood from the application, Bhalendra Nath Ray, Demonstrator and posted at Ambari Falakata, Sericulture, Jalpaiguri, died on 06.10.2004. The applicant being son of the deceased employee applied for an appointment under compassionate ground on 31.10.2005 followed by submission of the proforma application on 04.04.2006. Since he was not aware of any decision taken by the respondent authorities, he submitted representations on 03.08.2012 and submitted the pro-forma application

on 16.07.2018. Copies of some official correspondence revealed that his prayer was under process. But, it is evident that the competent authority has not yet taken any decision in this matter. Mr.G.Haldar, learned counsel has been advised to take instructions and update this Tribunal about the status of this case pending before the Commissioner by way of filing a report.
