The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The applicant has filed this application praying for setting aside the order of rejection vide no. 113 dated 09.01.2024 and for giving a direction upon the respondent authorities to give him an appointment on compassionate ground. His father, Munna Meerza had died on 29.01.2018. The applicant being the son of the deceased employee had prayed for an appointment under compassionate ground.

As submitted by Mrs. Mitra, the applicant has made several representations, last on 01.02.2024 on plain paper to the Estate Manager, Murshidabad Estate. The applicant continued to pray for his appointment and submitted representations to the respondent authorities, but till date no fruitful result has come.

Submission of Mrs. Mitra, learned counsel for the applicant is that despite being eligible and submitting several representations before the respondent authorities, the authorities are sitting tight over the matter and have not taken any decision till date.

Learned counsel, Mrs. Mitra submits that it would suffice if a direction is given to the respondent authorities to consider his prayer for an appointment under compassionate ground. Mr. Banerjee, learned counsel for the State respondents does not oppose.

Having heard, Respondent No. 4, the Estate Manager, Murshidabad Estate, Lalbagh, Murshidabad is directed to examine the prayer of the applicant for an appointment under compassionate ground. The applicant's side is directed to present his documents before the respondent no. 4, the Estate Manager, Murshidabad Estate, Lalbagh, Murshidabad within eight weeks from today. After
