Mr. Sunil Kumar Basu representing as Vice President of Constituted State Pensioners' Association, West Bengal has filed this application on behalf of the Association ventilating their grievances for awarding the pre-revised Scale No. 19, Rs.14300-400-18300/- (PB-5 with Grade Pay of Rs. 8700/-) to all the pensioners who are members of this Association. Submission of the learned counsel is that though the members of the Association would be entitled for such pay fixation but the same was deprived to them on account of arbitrary cut off date of **01.12.2012**. Mr. Kiran, learned counsel prays for a direction to the respondent authority to consider their prayer in this application, to which Mr. Banerjee, learned counsel submits that if such a direction is given, the same will be complied.

Having heard the submissions of the learned counsels and after examination of the prayers of the applicants who are pensioners, the Respondent No. II, Addl. Chief Secretary, Finance Department is requested to treat this application as their representation and dispose of the same as per rules within a reasonable period of time. The petitioners have also requested for an opportunity of hearing before this matter is disposed of. It would be advisable if Mr. Sunil Kumar Basu accompanied by 2/3 of his companions are allowed to ventilate their
