*The grievance of the applicant in the present application is that he was superseded by his juniors Srikumar Bhattacharya and Dipankar Ghosh on March 30, 2015 when the said juniors got promotion to the post of Chief Engineer. The contention of the applicant is that departmental proceeding was not started against the applicant on the date when his juniors were promoted from the post of Superintending Engineer to the post of Chief Engineer on March 30, 2015. The further contention of the applicant is that adverse entries in the ACR, if any, was never communicated to the applicant during the period from 2009 to 2014 which were considered for the purpose of promotion by the Departmental Promotion Committee. It is also contended on behalf of the applicant that he retired from service on August 31, 2017.*
