her deceased mother.

Under the above circumstances, the applicant is directed to file supplementary application disclosing the break-up of death benefits of her deceased mother by giving all necessary particulars and by enclosing copy of relevant documents within a period of next 8 (eight) weeks from this date.

The respondent no. 2, Chief Medical Officer of Health, Murshidabad at Berhampore is directed to submit a report with regard to entitlement of legal heirs of deceased Sadhana Malakar to receive death benefits like gratuity, GPF etc. and the amount of money which has already been disbursed as death benefits of the deceased Sadhana Malakar within a period of 8 (eight) weeks from the date of communication of this order.



Learned Registrar of the Tribunal is requested to communicate the copy of the order to the Chief Medical Officer of Health, Murshidabad at Berhampore before the ensuing Puja Vacation.
