the applicant is that he has not been granted promotion to the post of Supervisory Grade Typist while he was in service and as such the applicant has prayed for grant of promotion to the post of Supervisory Grade Typist and consequential financial benefits.

Having heard Learned Counsel representing both parties and on consideration of the materials on record, we find that the applicant retired from service as Grade I Typist on February 29, 2016. The Grade I Typists who were junior to the applicant in the Gradation List while the applicant was in service, got promotion to the post of Supervisory Grade Typist long after retirement of the applicant from service and as such the applicant is not entitled to get the benefit which was given to the Grade I Typist by grant of promotion to Supervisory Grade w.e.f. September 01, 2016. The application is, thus, misconceived and as such the same is **dismissed**.
