	daughter of the deceased employee, the Treasury

	Mr. A. K. Das Sinha, learned advocate for the	
	respondent nos. 2(c) to 2(i) submits that since it is	
	evident from the annexures annexed to the application	
	that all along it has been recorded that the date of birth	
	of the applicant was 12th November, 1990, no order	
	may be passed.	
	Heard learned advocates for the parties.	
	We have gone through the affidavit sworn by	
	Nira Basfore, wife of late Mohindar Basfore, stated to	
	be the mother of the applicant wherein it has been	
	stated that the date of birth of the present applicant	
	was wrongly recorded as 12th November, 1990 instead	
	of 28 <sup>th</sup> September, 1988.	
	Since we find that there are overwhelming	
	evidences - from the Voter Identity Card and Aadhar	
	Card that the date of birth of the applicant is 12 <sup>th</sup>	
	November, 1990, we are unable to rely on the affidavit	
	sworn by the mother of the applicant.	
	Moreover, as the marriage between Mohindar	
	Basfore, since deceased and Nira Basfore was	
	dissolved in terms of the order of the learned
